## Usage Rules for the Kletterwald in Waldkirchen

- Every visitor of the Kletterwald must read the usage rules before entering the facility. With signing the usage rules the visitor confirms that he has taken notice of and agrees to them. Under-age visitors need their legal guardian or their supervisor of legal age to read and discuss these usage rules with them before entering the course. In case of any questions do not hesitate getting in contact with the staff of the Kletterwald.
- Using the Kletterwald can be dangerous and takes place at the user's own risk. Wrong handling of the security techniques can lead to severe injuries or death! For entering the Kletterwald, it is absolutely necessary to wear sturdy shoes.
- The Kletterwald is suitable for visitors who are at least 110 cm tall, who do not suffer from a disease or mental or physical impairment, which on entering the Kletterwald could be a risk to one's own health or to the health of another person. Pregnant women cannot use the Kletterwald. The maximum allowed body weight is at 120 kg. Children under the age of 14 are not allowed to enter the Kletterwald without an adult or rather supervisor of legal age. Particularities referring to the minimum height and age for the individual courses can be gathered from a separate notice board at the entrance area.
- People who are alcoholized or have taken drugs are not allowed to use the Kletterwald. On entering the Kletterwald certain items such as sticks, bags, purses, rings, necklaces, bracelets, cellphones, and cameras and so on, shall not be carried along. Long hair must be tied up.
- The equipment rented from the Kletterwald Waldkirchen GmbH (helmet, belt, safety rope with snap hook and steel pulley) must be used as instructed by the staff. It cannot be handed over to others, cannot be taken off during the visit of the Kletterwald and must be returned afterwards.
- Every participant must attend the practical and theoretical safety demonstrations before entering the course and finally must complete the trainings course. Participants must absolutely adhere to all instructions by the staff. In case of any infringement or breach of the instructions given by the staff, these participants can be excluded from further visiting the Kletterwald.

CLIDNIAME:

- Snap hooks must always be hung up on the safety rope marked red. The rotary snap hook must always be pushed across the first plate (steel rope marked red) before entering the course. Additionally at the Flying-Fox-Course, the steel pulley must be hung up on the safety rope marked green.
- Each station can only be entered by one person. Each platform can carry a maximum of three persons at once. Before starting for the Flying-Fox-Course, the target area must be vacant.
- The Kletterwald Waldkirchen GbmH reserves the right to exclude persons, who do not adhere to the usage rules, from further visiting the Kletterwald. It also reserves the right to close the facility for safety related reasons (such as fire, storm, thunderstorms and so on). In this case and in the case of premature ending of the visit to the Kletterwald due to a participant, there will be no reimbursement of the entrance fee.
- So long as the participant does not expressly object to this, right after the photo or video has been taken, he or she agrees, that the Kletterwald Waldkirchen GmbH can use photos or videos taken of him for advertising purposes.
- The Kletterwald is located in a natural forest. Therefore on entering the course, minor injuries, such as skin abrasions, can occur and depending on the season one can get himself dirty (e.g. from tree resin or pollen and so on). For these kinds of damages the Kletterwald Waldkirchen GmbH does not assume any liability, unless it has acted out on intent or gross negligence.
- Moreover, the Kletterwald Waldkirchen GmbH only assumes liability, if a damage has been caused by its representatives or by its vicarious agents on gross negligence or intent. Liability for damages pursuant the product liability law, as well as for disregarding essential main duties and for violating life, body or the health of a participant remain unaffected from this limitation. The Kletterwald Waldkirchen GmbH expressly reserves the right to object to gross personal negligence. The claim for compensation for disregarding essential contractual obligations is limited to foreseeable damage typical of the contract concerned.
